

Clerical Tax Returns for the Pre-Reformation Diocese of Exeter Part 3: the 1513 Charitable Subsidy

Introduction¹

Lambeth Palace Library CM I/82 is a 60cm square of parchment.² It contains the names and preferments of clergy in the archdeaconry of Barnstaple 'both within the peculiar jurisdictions and outside' who contributed to Archbishop Warham's charitable subsidy of 1513.³

Background and analysis

As we saw in Part 2, charitable subsidies targetted poorer clergy who did not normally pay the tenth, the standard clerical tax of the later medieval English church. Granted by Convocation and administered and collected by the archbishop of Canterbury and his suffragans, they were readily resorted to in the closing decades of the fifteenth century and continued into the reign of Henry VIII as the crown's need for tax revenues grew.⁴

The 1513 subsidy was part of an ambitious package of financial measures voted by Parliament and Convocation of Canterbury Province to support the king in his wars with Scotland and France. The laity was subjected to direct taxation for the first time in over a century⁵ whilst Convocation's main contribution to the war effort was a grant of four tenths payable in instalments over the period 1513-16.⁶ Most beneficed clerics who customarily paid tenths were to contribute whether or not their livings had been assessed for the payment of tenths.

The charitable subsidy was a smaller affair and was due for collection between 27 March and 1 July 1513.⁷ It applied to four groups of clergy: stipendiaries (curates and parochial chaplains), clerics in receipt of pensions, priests serving chantries, hospitals and free chapels and incumbents who had been excused from contributing to the tenths by their bishops or who held unassessed benefices and who did not normally pay tenths but who were now deemed capable⁸ of contributing to the war effort.

Those caught by the subsidy were taxed according to their salaries or the value of their livings. Alien clergy paid at much higher rates than their native-born colleagues whilst clerics with incomes greater than £10 contributed 'pro rata'.⁹

Collectors were empowered to exempt native-born stipendiaries who were poor and studying at Oxbridge or who were too aged or ill to serve.¹² They were also to use ecclesiastical censures and 'other judicial remedies' to coerce those who refused to pay.¹³ The names of everyone due to contribute including those exempted were to be returned to the archbishop's agents in London by 1 July together with the money that had been gathered.¹⁴

A comparison with earlier charitable subsidies is instructive. In 1463, 38 clergy from the archdeaconry of Barnstaple contributed £14 5s 0d.¹⁵ Later in 1489, 130 clergy paid £43 3s 4d.¹⁶ Now in 1513, 192 clergy were to contribute £140 10s 4d.¹⁷ The scope of the subsidy and the amounts that individuals paid had increased significantly over the period.

I have italicised the names of those men who appear to have been graduates at some stage in their careers or who had a connection with higher education.¹⁸ They number 18 or roughly a tenth of the whole.

The manuscript

The schedule (as it is called in its heading) is in good condition and has been repaired in recent times. There is a small hole at the centre (probably caused by folding the document) whilst part of the right hand edge has also been lost. The six rural deaneries of the archdeaconry are listed in three columns on the front whilst the peculiars are recorded on the back. Some of the writing is rubbed and faded but can be read with an ultra-violet lamp.

The schedule is undated but internal evidence suggests that it was compiled in April 1513.¹⁹ It was sent to London 'annexed to' a certificate²⁰ which would have identified the subsidy. This has been lost but the schedule for the archdeaconry of Winchester still has its certificate. It is dated July 1513.²¹
