

Introduction

This website gives free access to my research into the later medieval and early modern diocese of Exeter. Its main aim is to publish calendars of the late fifteenth, sixteenth and early seventeenth bishops' registers and thus continue the sequence begun by Prebendary Hingeston-Randolph in the late nineteenth century. But other allied and worthwhile documents are also being transcribed. Supplementing the calendars are a series of databases. A final section makes available my PhD thesis and articles that I published several years ago.

The calendars and other items are PDF documents and are searchable using Ctrl + F (Windows) or Cmd + F (Mac). They will be updated at the beginning of each month to include new information or to correct errors.

My aim is to make the registers accessible to the ordinary reader. Whenever possible I have reduced the Latin text to a series of numbered entries in English. The content of each entry is determined by four questions: who, what, where and when. Material from other primary sources has been added where appropriate. These entries are identified by letters of the alphabet.

Dates are in the old style with the year taken as beginning on 1 January. Latin words are translated into English whilst Roman numerals are replaced with Arabic ones. Spelling of forenames and parishes is modernised, headings are shortened and brackets used to add information. The spelling of recurring surnames has been standardised whilst common surnames and placenames have been expanded without the use of brackets. Months of the year have been abbreviated. Pre-decimalization currency values and symbols have been retained: a £1 is 20 shillings (s) and a shilling is 12 pence (d); a mark is 13s 4d. The title 'dominus' routinely given to clerics has been omitted unless it is the only means of identifying an individual as a member of the clergy. Footnotes are principally used to establish the succession to ecclesiastical livings and to provide biographical details.¹

The diocese of Exeter approximated to the counties of Devon and Cornwall in the later medieval and early modern periods. It had almost 700 parishes and dependent chapelries which were grouped into 32 rural deaneries and four archdeaconries.²
