Introduction¹

A full introduction will be added at a later date. A few brief remarks about King's appointment and his register now follow.

Richard Fox was provided to Bath & Wells diocese on 8 February 1492.² He remained in charge at Exeter until his consecration which probably occurred on or shortly before 8 May when the *sede vacante* administration of Exeter diocese began.³

King was another ecclesiastic and civil lawyer who served both Edward IV and Henry VII.⁴ Appointed king's secretary in 1480 he fell out of favour under Richard III being arrested in June 1483.⁵ By December 1485 he was working for the first Tudor as a diplomat. In 1487 he became archdeacon of Berkshire and regained the royal secretaryship. King was provided to Exeter on 1 October 1492 having received custody of the see's temporalities the previous May and was probably consecrated at the beginning of February 1493.⁶ He was translated to Bath & Wells in November 1495.⁷

An extended record of the *sede vacante* period which formally ended on 1 March 1493 has survived in Archbishop Morton's register.⁸ Although this was edited some thirty years ago,⁹ I have gone back to the originals to correct a number of mistranscriptions and omissions and to expand upon some of the entries.

The *sede vacante* record greatly exceeds King's register both in quality and length. The latter is a scrappy, brief affair which has been hastily assembled.¹⁰ Unusually it starts on the verso of the final folio of Fox's register. King never visited his diocese and so the register is in fact his vicar-general's register. The various sections lack headings and there are a number of small parchment inserts. The inquisitions subregister comes before the institutions sub-register and may have been bound out of order.¹¹ It contains very few entries whilst the ordinations sub-register that follows the institutions sub-register ends abruptly in March 1494 some eighteen months before King moved to Bath & Wells.¹² Very probably a folio or more are missing at

this point.¹³ In common with the other later fifteenth century Exeter episcopal registers, there is no record of licences granted, mandates issued or correspondence received.

Proceedings and acts of M Robert Shirborne treasurer of Hereford cathedral¹⁴ and official, commissary and keeper of the spiritualities of the diocese of Exeter by authority of John Morton archbishop of Canterbury during the vacancy of the see following the translation of Richard Fox to Bath & Wells from 8 May 1492 to 1 Mar 1493

- 1. 8 May 1492: Morton, at Lambeth, commissions Shirborne and M James Adam BCL¹⁵ to serve as keepers of the spiritualities of Exeter diocese during its vacancy. They are to
 - inquire into the vacancies of benefices and admit and induct
 - sequestrate the revenues of benefices
 - receive oaths of obedience
 - visit the cathedral, religious houses, hospitals, clergy and laity of the diocese
 - inquire into excesses and crimes committed during the vacancy and correct misdeeds
 - examine, approve and expedite exchanges of benefices
 - inhibit any action prejudicial to the archbishop's visitation
 - register and grant probates where the probate falls to the bishop and lesser jurisdictions of the diocese and commit the administration of the goods of the deceased and of intestates to executors and those whom the law deems suitable
 - suspend the jurisdiction of inferior authorities for the duration of the visitation
 - receive custody of clerics accused of felony before the secular judges
 - remove those who are unsuitable from benefices and offices
 - punish the illicit farming of benefices
 - issue letters dimissory and letters of recommendation and commission any catholic bishop to ordain and examine ordinands
 - inquire into the appropriation of benefices or pensions and certify to the archbishop the names of the benefices and appropriators and the reasons for the appropriations
 - compel rectors and vicars to reside
 - defend all spiritual and ecclesiastical jurisdiction belonging to the bishop

 receive all spiritual revenues belonging to the archbishop by virtue of the vacancy, issue letters of acquittance for receipts and punish those who usurp the revenues

- 2. 21 May 1492: Shirborne orders the archdeacon of Exeter to cite the beneficed and unbeneficed of the archdeaconry to appear before the visitors on the days shown below. Three or four trustworthy laymen from each parish are also to be cited to appear. At the visitation sessions procurations are to be paid according to custom¹⁶, clergy are to show letters of institution, dispensations from defects of birth, letters of ordination and dispensations for pluralism. They are also to give details of appropriations and pensions payable from their churches. The archdeacon's jurisdiction is inhibited from the date of receipt of Shirborne's mandate. The archdeacon is to certify that he has executed the mandate by Monday 4 Jun¹⁷ in Exeter Cathedral:
 - Friday 1 Jun¹⁸: visit Exeter Cathedral in chapter house
 - Saturday 2 Jun: visit Christianity deanery in St Mary Major Church
 - Sunday 3 Jun: continue visitation because it is the first Sunday
 - Monday 4 Jun: visit St Nicholas' Priory Exeter where lunch is to be taken
 - Tuesday 5 Jun: visit St John the Baptist's Hospital Exeter¹⁹ where lunch is to be taken and Polsloe Priory
 - Wednesday 6 Jun: visit Kenn and Dunsford deaneries in St Thomas-by-Cowick Church and take lunch in Exeter
 - Thursday 7 Jun: visit Aylesbeare deanery in Ottery St Mary Collegiate Church where lunch and dinner are to be taken and spend the night there
 - Friday 8 Jun: visit Ottery St Mary Collegiate Church where lunch is to be taken and spend the night at Honiton
 - Saturday 9 Jun: visit Honiton and Dunkeswell deaneries in Honiton Chapel where lunch is to be taken and spend the night at Exeter
 - Thursday 14 Jun²⁰: visit Plymtree deanery in Cullompton Church where lunch and dinner are to be taken and spend the night there
 - Friday 15 Jun: visit Canonsleigh Abbey where lunch is to be taken and spend the night at Tiverton
 - Saturday 16 Jun: visit Tiverton deanery in Tiverton Church where the night is to be spent

3. 31 May 1492: John Tyack²² official of the archdeacon of Exeter certifies that he received Shirborne's mandate on 24 May. He appends a schedule of the names of those cited to appear before the visitor.
