

Clerical Taxation Returns for the Pre-Reformation Diocese of Exeter Part 1: General Introduction and the 1406 Clerical Subsidy

General Introduction

The returns are taken from local and national sources.¹ The criteria for inclusion are completeness and legibility. The returns provide useful snapshots of the diocesan clergy across the period and therefore serve as substitutes for the absence of visitation records.² Disappointingly, none of them provides a full picture of the clerical workforce as visitation call books might be expected to do.³ This is because not all of the clergy were required to contribute to the taxes whilst some of the returns for the archdeaconries of the diocese – the standard unit of return – are missing. ‘Completeness’ is therefore a relative term.

The years covered are 1406, 1489, 1513, 1522, 1538 and 1540. Each return (or Part) has its own introduction which provides a brief historical context, a description of the manuscript, an analysis of the return’s contents and an account of the editing procedures employed.

Footnotes record scribal comments, contemporary names of parishes and variant spellings of surnames. They also provide biographical information about the clergy.⁴ University graduates or attendees are italicised in the body of the returns.⁵ ‘Graduate’ means master of arts unless otherwise stated.⁶ ‘Stipendiary’ is a catch-all designation for curates, chantrists and assistant clergy. Emboldened entries (chiefly in Parts 4 and 5) indicate clergy who were (or who may have been) involved in the clerical taxpayer strikes of the 1530s.

A note on Emden

Emden is my shorthand for A B Emden’s biographical registers of the students and graduates (predominantly clerics) who attended Oxford and Cambridge Universities

in the later middle ages and early years of the sixteenth century. When these volumes were first published in the 1950s and 60s they were rightly seen as a major prosopographical achievement. But the passage of time has inevitably produced cracks in the edifice. The registers understate the number of university attendees whilst a good deal of additional information could be added to the entries that do exist. There are also many factual inaccuracies. Nicholas Orme's recent work on Cornish students at Oxford shows the possibilities.⁷ Emden's novelty was to go beyond the university records and search among diocesan and other archives; it is upon this that the following rests.⁸

The Clerical Subsidy of 1406

Introduction

We start at the beginning of the fifteenth century with the returns for 1406 which are among the earliest surviving clerical subsidy rolls for the diocese. They are of good quality and survive for three of the four archdeaconries: Cornwall, Totnes and Barnstaple.⁹

Background and analysis

Henry IV, formerly Henry duke of Lancaster, usurped the throne in 1399. His regime lacked stability, friends and money and was forced into borrowing against the collateral of taxation.¹⁰ Fortunately Archbishop Arundel was a skilful manager of Canterbury Convocation and secured a regular flow of revenue from the clergy of the southern province throughout the king's reign.¹¹ Altogether 21 half tenths were voted, 12 of which were collected in the first seven years.¹² The 1406 subsidy was part of this initial tranche and was raised on clerics who did not pay tenths.¹³ It was by no means popular and Convocation imposed a number of conditions: that the proceeds were to be applied to the defence of the realm and the church by the advice of the king's council, that the levy was not to be used as a precedent and that no collectors were to be compelled to make payment at the Exchequer before the due date which was 8 July.

Almost at once there were problems as many clergy liable for the subsidy sought to escape it by fleeing to religious houses and other privileged places that had been exempted from the tax. Henry and Arundel were alive to this and ordered the collectors who were usually heads of monasteries to seek out the escapees. It all took time and money was still being gathered in early August when the crown desperate for revenue threatened a number of collectors with fines for dilatoriness.

The unpopularity of the subsidy was understandable as it revived memories of the poll taxes of the early years of Richard II's reign.¹⁴ A flat rate of 6s 8d was imposed on stipendiary chaplains, both religious and secular, mendicant friars, chantry priests and beneficed clergy who did not pay tenths because their livings were not included in the 1291 *Taxatio*, the source book for late medieval clerical taxation.¹⁵ This contrasted with the charitable subsidies of the later fifteenth

century which used graduated rates in acknowledgement of the varying incomes of the lower clergy.¹⁶

Clearly there was much haste about the levying of the tax. Only three weeks separated the granting of the subsidy on 16 June and its due date.¹⁷ Both bishops and collectors were under pressure. Diocesans were given until 1 July to appoint collectors and certify their names to the Exchequer. At Exeter Bishop Stafford chose the prior of St German's and the abbots of Buckfast and Hartland.¹⁸ Once appointed the heads had to arrange for agents to visit the parishes, take down names and gather in the money.

It is likely that the names that appear in the returns were quickly recorded at the end of June or the beginning of July which may explain why many of the entries lack surnames. However, the returns themselves may not have been completed and filed until later probably because of difficulties in collecting the tax. The preamble to the return for the archdeaconry of Barnstaple reports that the abbot of Hartland's attorney or agent, Nicholas Porter, paid his clergy's contributions to the Exchequer after Michaelmas.¹⁹

Some 443 clergy contributed to the subsidy of which 203 were rectors or vicars and 240 chaplains or chantry priests. Almost all were local men with an average age of 45.²⁰ At least 28 were graduates or had spent some time at university. The number of unbeneficed is suspect and suggests a significant under-recording of assistant clergy who may well indeed have gone into hiding to avoid the tax. Almost all parishes in the diocese had stipendiaries. As there were over 400 parishes and dependent chapelries in the three archdeaconries we should expect a much larger number of contributors especially as churches often had more than one assistant cleric serving them.

Nationally it is estimated that over £3400 net of expenses was brought in by the subsidy which approximates to £2 million in today's money.²¹ The three archdeaconries' share was £150 or £88000. Compared to the charitable subsidies later in the century the yield is unremarkable and reinforces the impression that the 1406 grant was a rather blunt instrument which failed to produce as much revenue as its promoters hoped.

The manuscripts

The returns, which are part of the E179 series in The National Archives, are recorded on small, narrow parchment rolls, one for each archdeaconry.²² Those for Cornwall and Totnes comprise three membranes sewn head to tail whilst the roll for Barnstaple is a single membrane more properly called a rotulet.

Although generically similar each return has its own characteristics. That for the archdeaconry of Cornwall lacks a heading and is indented along the full length of its right hand edge. The scribe has used the left hand margin to note clerics who were rectors and vicars in addition to doing so in the body of the return and he has also recorded the number of clergy in each deanery. At the end there are summary totals of rectors, vicars and chaplains; no mention is made of money. In contrast the returns for the archdeaconries of Totnes and Barnstaple have headings which provide the names of the collectors and recite the terms of Convocation's grant. There are no indentations and no running totals of clergy. The Totnes return gives a summary total of clerics together with the amount of tax assessed whilst the Barnstaple return records 6s 8d in the right hand margin against each cleric as well as providing a grand total at the end.

Editing

I have standardised the format of the returns to create a continuous document. I have extended the practice of recording the number of clerics for each deanery to the whole document and added summary totals of clergy and tax assessed for each archdeaconry. I have omitted the headings of the returns for the archdeaconries of Totnes and Barnstaple, the annotating of rectors and vicars in the Cornwall return and the 6s 8d levied on each cleric in the Barnstaple return.
